#### **OBJECTIVES AND INVESTMENT POLICY**

We aim to deliver a greater total return than the Consumer Price Index (CPI) measure of inflation + 5%, after fees, over any rolling five-year period by investing with our Liquidity, Equity-type risk, and Diversifiers (LED) framework. Total return means the return wereceive from the value of our investments increasing (capital growth) plus the income we receive from our investments (interest and dividend payments). We use the CPI + 5% as a target for our fund's return because we aim to grow your investment significantly above inflation.

We aim to deliver this return with no more volatility than that of the FTSE Developed stock market index. As an indication, if global stock markets fall our fund value should be expected to fall by around that amount. Because we measure volatility over a five-year period, some falls may be larger or smaller over shorter periods of time. We aim to limit the amount of volatility risk our fund can take because we want our investors to understand the risk they are taking in terms of the global stock market.

We split our fund's investments between three categories, which we call our LED O% and 20% in Liquidity assets. These can be sold easily and dampen volatility, but they also lower your potential return. We can invest between 70% and 100% in Equity-type assets. These include shares and anything that behaves like shares, which are the best tools to beat inflation and grow your capital, but they are also more volatile. We can invest between O% and 20% in Diversifiers. These assets behave very differently to stocks and bonds, which reduces volatility and adds a layer of protection to your investment. These limits are reviewed annually or in response to changes in the market.

Our fund invests globally in the following:

-Government and corporate bonds, with no restriction on their credit quality

-Listed company shares

-Actively managed funds

-Passively managed funds

-Structured products

-Derivatives for hedging

Up to 10% of the fund can be invested directly in contingent convertible bonds. These specialist bonds, typically issued by banks and insurers, are forcibly replaced with shares if the issuer experiences heavy losses.

We can choose to hedge our overseas assets back to sterling. Hedging means we buy a financial instrument to swap the value of these assets into sterling to protect our investment from changes in the price of foreign currencies.

We actively manage our fund, which means we can choose what we invest in as long as it's in line with the investment objective and policy. Because of this, our fund's performance can diverge significantly from its benchmarks over shorter periods of time and herefore isn't appropriate for investors who plan to withdraw their money within five years.

Our fund is designed for investors with a basic knowledge of multiasset investments who seek growth. You should intend to invest for longer than five years, understand the risks of our fund and have the ability to bear a capital loss. You can buy and sell shares in the fund on each business day of the fund between 9am and 5pm.

The fund offers accumulation shares (shares in which any dividends received are added to the share price).

#### **RISK AND REWARD PROFILE**

Counterparty risk: A company that we deal with may renege on its obligations,

costing you money

Interest Rate Risk: Most bonds pay us a fixed amount over an agreed period of time. If interest rates rise these bonds become less valuable and we may be locked into an unfavourable investment. If interest rates fall these bonds become more valuable

Credit risk: Bonds that we own can become more or less creditworthy and will fluctuate in value resulting in gains or losses. Bonds that we own may fail to meet their legal obligations, such as missing an interest payment. This is known as a 'default' and will result in a loss.

Operational risk: We rely on complex systems to ensure that trades are completed, our fund's assets are accounted for and that you can buy or sell our fund. If our systems fail, you could be inconvenienced or lose money.

Derivatives risk: Sometimes we use financial contracts, such as structured products and currency hedging, to reduce risk. There is a chance that these derivatives won't work in the way we intended, which could result in unexpected gains or losses.

Management risk: People make the investment decisions for our fund. If they make unfavourable decisions, you could lose money.

Currency risk: We own assets valued in a currency other than sterling. Changes in the price of foreign currencies can result in gains or losses, even if underlying asset prices stay the same.


